3	Consolidated Pay	Rs. 16,000/- per month for 04 (four) monthly visits (weekly once with four hours duration) in case additional visits required Rs. 1000/- per hour will be paid accordingly.
4	Tenure	Initially for 01(one) year, extendable upon satisfactory performance at the sole discretion of NIPER- Kolkata.
5	Leaves	As the engagement is on visit basis therefore no leaves are entitled / eligible to the individual selected as Visiting Student Counsellor.
6	Essential Qualification	Bachelor's Degree in Psychology with minimum 60% marks from recognised University with relevant experience of five years after the qualifying degree, out of which three years should be student counselling experience in a higher educational institution. OR Master's Degree in Psychology with minimum 60% marks from recognised University with relevant experience of three years after the qualifying degree, out of which minimum one year should be student counselling experience in a higher educational institution.

8	Job Description	<ul style="list-style-type: none">• The counsellor would render counselling service to all the bona fide students as required and be available to staff and faculty of NIPER-Kolkata during the working hours and in the working days only.• The counsellor would be the point of contact for students if they require interpersonal/ emotional counselling.• He/ She must be comfortable working with students from a variety of socio- economic backgrounds.• The counsellor shall have excellent communication skills in Bengali, Hindi and English language.• The counsellor will maintain confidentiality but report to Dean, NIPER- Kolkata of any extreme cases that demand Institute/ family intervention (Related to students).• The counsellor shall have proper coordination with the Institute Medical Officer for rendering counselling.• Tele consultation as and when required with students and staff.

		<ul style="list-style-type: none"> • The counsellor shall conduct workshops, talks, and group discussions from time to time to help students with their academic, interpersonal, and emotional needs. • The counsellor shall conduct separate orientation sessions to students as well as Teaching and Non- Teaching staff of the Institute once in a year at the beginning of the Academic Session. • The Student counsellor shall maintain a database of the mental well-being of the students who takes up the counselling services. • Service of the Student counsellor may be terminated by giving 01 (One) month notice by either side.

1. Candidates of Indian nationality can only apply for these posts. Preference will be given to the candidates staying in Kolkata.
